Since November 2009, Fuchs has been deputy chairman of the CDU/CSU parliamentary group in the German Bundestag. He was previously managing director of Impex Electronic which he founded in 1980 in Koblenz and 1984 in Hong Kong. From 1992 till 2000, he was president of the National Federation of German Wholesale and Foreign Trade (BGA) in Bonn and Berlin as well as vice president of the Federation of European Wholesale and International Trade Associations (FEWITA) in Brussels. Dr. Fuchs is a member of numerous company boards as well as of the board of the Ludwig-Erhard-Foundation. He is Executive Senior Advisor or WMP Eurocom AG. Dr. Fuchs received his Ph.D. in pharmaceutical studies in 1976.
